## Stonebridge Wild River Reserve attracting more new species

ARK's latest moth nights have continued to record new species.

In August 106 moths were caught, with at least ten new species for the site, including Palpita vitrealis, an immigrant typically found in southern coastal counties, rarely elsewhere.

In September 62 moths of fifteen different species were caught. ARK's Moth Group has logged 135 species, including the Grass Rivulet which is classified by IUCN (International Union for Conservation of Nature) as endangered. This is a moth that has shown a decline of 96% over the last 35 years and is associated with grassland of the type found in the meadow. Currently the areas of highest value to moths and their caterpillars are the scrub area and areas of grasses, reeds and trees.

As the current habitat restoration project continues to restore what was for many years a neglected patch of land the number and diversity of moths should increase with the addition of a wildflower meadow creating a new habitat.

Moths, like butterflies are highly sensitive indicators of the health of the environment. They play a vital role in pollinating plants and are crucial to the food chain.

Monthly moth trapping evenings run from April to November, are open to the public, and free. The next one will be on Friday 4 October. For more information contact: <a href="mailto:anna@riverkennet.org">anna@riverkennet.org</a> 01672 511028.
